Presentation of 2024 Financial Statements

nancial Performance

- ► Total revenue of \$2.007 M (increased from \$1.738 M in 2023)
- Total expenses of \$1.577 M (increased from \$1.432 M in 2023)
- Profit before amortization and gain on sale of assets \$495,657
- Amortization \$208,926
- ► Gain on sale of equipment \$12,774
- Surplus for the year \$299,505

on 1 June 3, 2025 4



nancial Performance

- ► Total revenue of \$2.007 M in 2024 vs. \$1.738 M in 2023
- Membership revenue increased by \$26,000
- Green fees increased by \$87,000
- ► Bar sales increased by \$34,000
- Golf cart rentals increased by \$25,000
- Interest income is up \$3,000
- Advertising and miscellaneous revenue is up \$121,000



nancial Performance

- Included in the miscellaneous revenue were:
 - ► A generous anonymous donation (approximately \$100,000)
 - Carbon Canada rebate \$14,000
 - ► Forgiveness of the CEBA loan \$10,000



nancial Performance

- Expenses were \$145,000 higher than the previous year
 - There were several areas for the increase:
 - Wages were up by \$87,000 (minimum wage, increased staffing due to a longer season in 2024 versus 2023)
 - Greens were up by \$18,000 due to inflationary factors
 - ► House was up \$24,000 with higher repairs and maintenance costs
 - There was a reduction in professional fees as legal fees were reduced as the transition to the new NPO act was completed



y Highlights

- Substantial investment in course improvements and equipment with more than \$367,000 of investment
- Additional investment was made subsequent to year end in new maintenance equipment



y Highlights

- ► The club was holding \$830,000 in cash and GIC's at year end (similar to the prior year)
- ► The cash balance includes \$130,000 in deferred revenue from memberships paid in advance for the 2025 season

▶ The net assets of the club were at \$1.97 million



2025 Outlook

- ▶ Budget is set to generate a surplus of \$118,000
- ► Included in the budget is depreciation of \$175,000 to allow for the reinvestment into the course (upgrades and equipment)
- ► The net cash flow to the club in 2025 available for reinvestment is projected to be \$250,000. This is in addition to the available cash

RESOLVED AS AN ORDINARY RESOLUTION OF THE CLUB THAT the firm of Kelly Huibers McNeely be appointed as the Club's accountant for purposes of conducting a review engagement of the Club's financial statements, until the next annual meeting of Members or until a successor is validly appointed, at a remuneration to be fixed by the Board of Directors.

2024 Course Projects

Bunkers

- ▶ Filled in and sodded back half of big R/H bunker at 17th green.
- Added sand to all greenside bunkers

Tee Boxes

- ▶ Built the remaining three permanent Red tees (Holes 14,16 & 17)
- Extended the Blue tee on 14
- ▶ Levelled the tee box on 16

Top Dressing of Fairways

► Fall top dressing of fairways on hole 1, 3 and 4 to help with drainage

Repaired the drainage behind the 3rd green

liscellaneous

- Rebuilt the retaining wall at the 18th green ground entrance to the club house
- Purchased three boxes for divot mix and bottles for the 10th tees and pro shop. Installed a second divot bottle on carts
- Cleaned up the area left of the 14th White tee with fill and topsoil
- Cleaned out the area behind the 2nd green
- Removed the old rain shelters and installed eight new ones

Tee Boxes

- ▶ Remove front Armour stone walls on #3 White and Blue tees

2025 Course Projects (Cont'd)

Drainage

- ▶ Replace culverts and bridges at #14 tee, #15 fairway and the #17 Gold and Blue tees
- ▶ Remove old drainage along R/H side of #15 fairway to the creek and install new drainage - completed at the end of the 2024 season
- Install additional drainage as required

Greens

► Enlarge the 10th green

Top Dressing of Fairways

Spring and fall top dressing of fairways on hole 1, 3, 4, 6 and 11 fairways to help wit drainage

Miscellaneous

- ▶ Clean up the area and pond right of the Gold tee on 14
- ▶ Plant 15 new trees
